Make your reservations at the Baymont Inn in Grove City, Ohio. Ask for the Special Canal Society of Ohio rate of \$ 92+ tax per night. This rate is good until Our block of 30 rooms is reserved and must be completed by April 8.. Make your reservation as soon as possible!

PLANNED ACTIVITIES INCLUDED

This tour will include many interesting remnants of the Ohio & Erie Canal and the Columbus Feeder. The tour will start at Columbus’ Bicentennial Park where the Columbus Feeder basin was during canal era, Shadeville, the guard lock and Lock 2 at Big Walnut Creek, Locks 30 and 29 at Lockbourne, the staircase of lock at Lockbourne, Groveport Historical Museum and Lock 22, Canal Winchester and Waterloo. After lunch, we will visit the slackwater crossing at the Little Walnut Creek with Lock 18 and guard lock and the original cut stone dam site. After viewing the crossing, we will tour Locks 11 thorough 16 in Lockville. After this, we will see the Fairfield County Historical Parks restored grist mill, Rock Mill. This is an early example of a water-powered mill typical of those found on the canals in Ohio.

PROGRAM

Friday, April 28: Sign in opens at 6:00 PM in the Groveport Historical Society facility at Historic Groveport Town Hall in Groveport, Ohio which is located at the northwest corner of Front and Main Street in Groveport. (Pre-Registration required.) Get together and preview slide show at 7:00 PM by Dave Neuhardt detailing the tour for Saturday. Free to all. Light refreshments will be served. Tables will be available for displays and sales items.

Saturday, April 29: Late sign-in opens at 7:45 AM in the hotel lobby (Pre-Registration required) The bus tour of the canal departs at 8:00 AM to Columbus as we start at Bicentennial Park.

Saturday Night, April 29: Banquet will be held at Berwick Manor Party House at 3250 Refugee Road in southeast Columbus, Ohio. It is 8.7 miles from our headquarters on Alum Creek to Route 33.
